#### Trustees Report for the Year Ended 31st March 2019

#### **Chairman's Report on behalf of the Trustees**

Dunfermline Athletic Heritage Trust was established on 18 October 2014, by a Trust Deed, with the aim of preserving for future generations the history of Dunfermline Athletic Football Club and the memories of its players, management and supporters, and making this rich heritage available for public access.

Although we share a common interest in the past, present and future of Dunfermline Athletic FC, the Trust is completely independent of the football club, with its own governance system run by Trustees who are all long-term Pars supporters.

These are the fourth accounts of the Trust and cover the period from 1 April 2018 to 31 March 2019.

Dunfermline Athletic Heritage Trust is a charity registered in Scotland, No SC045532.

#### **Activities of the Trust**

The Trust continues to be extremely active, and its work is broken into a number of work-streams. Trustee and volunteer meetings are held quarterly. All activities are carried out by unpaid volunteers.

The Trust carried out an on-line and paper survey into its present activities and how these might be developed in the future. There were 81 responses, and the thrust of the feedback was that online services such as the video interviews of former players and the Facebook page were most popular, although there was support for publications, exhibitions and one-off events. There is a small but passionate group of supporters concerned with the history of Dunfermline Athletic, and they are likely to be helping DAFC already in different capacities. Whilst a museum would be

welcomed, there was a real doubt over the sustainability of such a venture. An unmanned heritage space might be an alternative.

**Tangible Heritage** – There is now a series of panels in public areas of both the Norrie McCathie stand and also the Main stand, which tell the history of the club, the ground, and Dunfermline Athletic record breakers. Further work is on-going to put further panels into the hospitality boxes which would tell the history of DAFC in Europe.

A Collections Development Policy had been developed and it is intended to proactively shape the tangible heritage collection, with an emphasis on quality items. In this connection, the Trust acquired the 1925/26 league championship medal awarded to John Fraser, President of DAFC, and was donated a rare inter-war greyhound racing programme from East End Park.

**Statistical Heritage** – A trial site has been developed to test how statistical information, programmes, match reports, photographs and player profiles might best be displayed on-line.

**Photographic Heritage** – The photographic archive is an important and valuable resource. There is a very considerable task of tagging the collection which needs to be undertaken if the collection is to be useable to its full extent. Some rare glass plate negatives from 1958 were purchased at auction.

**Audio-Visual Heritage** – Interviews with former players, club employees and supporters continue to be extremely popular. Most of the more senior ex-players have now been interviewed and recorded, and additions are made on a very regular basis, especially where they fill an important gap in telling the story of Dunfermline Athletic through the eyes of its players.

**Historical Heritage** –The Trust helped to fund a historic blue plaque at the Old Inn, which was the site of the foundation of Dunfermline Athletic in 1885. It was formally unveiled by Jim Leishman, Provost of Fife, and now a Trustee, on 14 June 2018.

The Trust provided an information board on the outside wall of East End Park to honour the memory of David Hunter VC, a long-time supporter of Dunfermline Athletic. This is behind a memorial plinth (which contains a time capsule of Hunter and DAFC items) and VC stone. It was unveiled at a public ceremony on 16 September 2018 which was attended by the Lord Lieutenant of Fife, the Provost of Fife, The Maire and Councillors of Moeuvres in France (where David Hunter won his VC), and 300 members of the public. An ensuing memorial lunch and sale of special commemorative football shirts raised funds both for the Trust and also PoppyScotland.

**IT and Digitisation** – The Trust runs both a website and a Facebook page. The website focusses on matters of more permanent interest, whilst the Facebook page contains articles of current interest, and is well used.

There are large projects underway to digitise and make available Dunfermline match-day Programmes, and articles about Dunfermline matches from local newspapers. This will be integrated with the statistical information and player profiles. A suitable platform is being tested.

#### **Financial Review**

The income of the Trust for the year can be broken into two main elements. Firstly, fundraising and donations represents the considerable efforts of many to put funding into the Trust via gifts, donations and money raised from social events. The Trust is very grateful for the generosity of its supporters. Secondly, funds were raised in September 2018 as a result of a lunch and shirt sale which related to the centenary of David Hunter winning the Victoria Cross in France.

The largest item of expenditure of the Trust, in the year, was in relation to the display boards telling the history of club, ground and players. These have been placed in public spaces around the ground. There was significant expenditure on the President's gold medal which comes from Dunfermline's first championship winning season in 1925/26. In addition, the Trust were heavily involved in securing a blue plaque for the Old Inn to mark the site of Dunfermline Athletic's founding in 1885.

#### **Appointment of Trustees**

There must be at least six Trustees and a maximum of twelve. The initial Trustees noted above were appointed for three years from 18 October 2014. Trustees are appointed or re-appointed at a special meeting of Trustees convened for that purpose, and after the initial Trustee appointments, are appointed, or re-appointed, for a period not exceeding two years. Trustee meetings are held quarterly, and are also attended, in an observer capacity, by the volunteers who are not Trustees.

On 5 November 2018, Donald Adamson, Craig Brown, Brian Duncan, Graeme Herd and Kenny Mclachlan retired as Trustees and were reappointed for two years until October 2020.
