## **Trustees Report for the Year Ended 31<sup>st</sup> March 2020**

### **Chairman's Report on behalf of the Trustees**

Dunfermline Athletic Heritage Trust was established on 18 October 2014, by a Trust Deed, with the aim of preserving for future generations the history of Dunfermline Athletic Football Club and the memories of its players, management and supporters, and making this rich heritage available for public access.

Although we share a common interest in the past, present and future of Dunfermline Athletic FC, the Trust is completely independent of the football club, with its own governance system run by Trustees who are all long-term Pars supporters.

These are the fifth accounts of the Trust and cover the period from 1 April 2019 to 31 March 2020.

Dunfermline Athletic Heritage Trust is a charity registered in Scotland, No SC045532.

### **Activities of the Trust**

The Trust continues to be extremely active, and its work is broken into a number of work-streams. Trustee and volunteer meetings are held quarterly. All activities are carried out by unpaid volunteers.

**Tangible Heritage** – Further work is on-going to put panels into the hospitality boxes which would tell the history of DAFC in Europe.

The Trust intends to improve its display facilities in the foyer next to the Cub Shop and Ticket Office. This includes consideration of a bespoke display cabinet.

**Statistical Heritage** – A test year was selected to demonstrate on a test site how statistical information, programmes, match reports, photographs and player profiles might best be displayed on-line. The outcome was encouraging, and we hope to see this made public in the forthcoming year.

**Photographic Heritage** – The photographic archive is an important and valuable resource. There is a very considerable task of tagging the collection which needs to be undertaken if the collection is to be useable to its full extent.

**Audio-Visual Heritage** – Interviews with former players, club employees and supporters are extremely popular. The Trust works closely with the Former Players' association to ensure as comprehensive a recording of memories as is possible. Most match days sees an interview being recorded and then released through the Trust Facebook page.

**Historical Heritage** – The Trust facilitates the annual Remembrance Day commemorations at East End Park. It was awarded a full grant to acquire seven perspex outlines which represent the seven DAFC players who we are aware of who were killed in the First World War. These each take a seat within the ground on the Remembrance Day game.

**IT and Digitisation** – The Trust runs both a website and a Facebook page. The website focusses on matters of more permanent interest, whilst the Facebook page contains articles of current interest, and is well used.

There are large projects underway to digitise and make available Dunfermline match-day Programmes, and articles about Dunfermline matches from local newspapers.

## **Financial Review**

The income of the Trust for the year arises from voluntary fundraising efforts by the Trustees and supporters.

The largest item of expenditure of the Trust, in the year, was in relation to the purchase of prints for a forthcoming art exhibition. This would have happened on March 21 2020 had the global pandemic not closed the stadium. These prints are of three new paintings which celebrate three European competition games played at East End Park. Most of the prints have been pre-sold and will be signed by former players who played in the relevant games. A substantial profit is anticipated in 2020/21 when the delayed exhibition is eventually held.

## **Appointment of Trustees**

There must be at least six Trustees and a maximum of fifteen. The initial Trustees were appointed for three years from 18 October 2014. Trustees are appointed or re-appointed at a special meeting of Trustees convened for that purpose, and after the initial Trustee appointments, are appointed, or re-appointed, for a period not exceeding two years. Trustee meetings are held quarterly, and are also attended, in an observer capacity, by the volunteers who are not Trustees.

On 18 November 2019, Duncan Simpson, Christine Scott, Bonar Mercer and Jim Leishman retired as Trustees and were reappointed for two years until October 2021. Gordon McKenzie and John Simpson retired on that date, and although no longer Trustees, we are grateful to them for their past services and continuing support.

### **Appointment of Independent Examiner**

**Independent Examiner’s Report to the Trustees of Dunfermline Athletic Heritage Trust SC045532.**
